

Space is being requested to accommodate State Audit. APSU is required by statute to have an annual financial audit that includes all fiscal aspects such as Accounting, Student Accounts, Financial Aid, student records, Purchasing, Human Resources, Budgeting, Grants, Capital Projects, etc. The legislative branch that accommodates the statute is State Audit. Generally, four to five auditors are physically on campus eight to nine consecutive months each year to complete the audit.

Previously, State Audit has been temporarily housed in different locations depending on what available space was available. They have been housed in the area commonly referred to as the Green Room in Clement however, that space was provided to Development for fund rasing activities. They have been housed in the IT server section, but was relocated due to the relocation of the Help Desk staff. Most recently they have occupied a space that was inadequate to their staff, and requirements of technology needs. The auditors require desk space to accommodate four to five auditors on a daily basis plus space for the manager that comes periodically for site reviews; network connection to the university network; internet connection; university provided computer for network access to Banner, e~Print, Argos, and network file shares, university provided telephone that is accessible to campus network, and a printer. Additionally, the space must be reasonable for campus access as much of their time is spent interviewing, and reviewing work and processes of many areas on campus.

As it is incumbent upon the university to provide adequate working environment for the auditors, I would like to propose the space formerly used, and now vacated by the Upward Bound program located at Polk Street (stand alone house owned by the university). This space is currently partially occupied by the Help Desk, and was also a co-occupant with the Upward Bound program.

The auditors typically arrive on campus between Thanksgiving and January 1 each year.

An alternative space such as another renovated house such as one on Marion Street would also be suggested. The auditors have historically been all females, so safety and location would also be a concern.
