Stunning library display to star at June meeting

spectacular new Woodward Library display of APSURA photos and articles has become the centerpiece of a very busy late-spring season for APSURA. The display, designed by the Library's Gina Garber and Christina Chester-Fangman, features a large ceiling-mounted array of poster-size photos of APSURANS involved in activities ranging from Ireland bicycling to New Zealand heli-skiing to clambering among Turkish and Peruvian ruins. One young student viewing the display was heard to say, "This looks more like an adventure club than a bunch of old people." (To which I would like to reply, "You are on the right track, son.")

A group tour of the display will be a feature of the APSURA annual membership meeting on Wednesday, June 4, along with a presentation on library opportunities by Woodward Library director Joe Weber. This meeting will at 3 p.m. in MUC 103A, and will include socializing as well as elections to replace officers and directors whose terms are expiring. We will also discuss local and regional travel possibilities for this summer and fall, as discovered by travel chairman David Kanervo. We look forward to seeing many of you at this meeting!

Other APSURA events of current interest are the recent interviews with presidential candidates, our meeting with new retirees at their dinner on April 30, a trip to the spring festival at historic Rugby coming up on May 16-17, and preparations for conferences of the state and national retirees associations. We were honored to be included in the process of interviewing the four finalists for APSU president. We hope our input to the search committee and the Chancellor will have helped them find the very best successor to Presi-

dent Hall. Jim Clemmer and I were also honored to be asked by Human Resources to represent AP-SURA at the retirees dinner, where we invited new retirees to join APSURA and gave them copies of

recent newsletters and our new brochure. Several had already joined following our November seminar.

The library display features postersize photos and articles from past APSURA newsletters suspended from the ceiling and in three display cases. A number of APSURANS are heading to historic Rugby for the spring festival on May 16-17. The festival is one of the premier events of the year at Rugby, and includes a full slate of Appalachian music, crafts, food, storytelling and maypole dancing (see www.historicrugby.org). We will drive up individually on Friday morning, May 16, attend the festival, and stay the night at the Grand Vista Hotel in Huntsville. Huntsville is north of Crossville, a 3-hour drive from Clarksville. If you would like to join in this excursion, rooms might still be available at the Grand Vista for around \$77 (1-888-854-6300). This would be a pleasant excursion.

Several of us will be attending the conference of the national Association of Retirement Organizations in Higher Education (AROHE) in Minneapolis August 10-12, where Jim Clemmer will deliver a presentation on our November seminar for new retirees. And this year



APSURA will be planning and directing the annual conference of the Tennessee Higher Education Retirees Association (THERA) on November 2-3 at Fall Creek Falls State Park. Please plan to attend this conference if you can, as it provides a good overview of what other state associations are doing as well as providing a great fall weekend at beautiful Fall Creek Falls.



We are also happy to announce that we finally have an office on campus! It is Claxton 302F, and we have file space, a computer, a printer, and—most important—a coffee pot. Your officers and directors look forward to using this office for some of our business.

We hope to see some of you at Rugby on May 16, and many of you at our membership meeting on June 4!


















Spring has sprung for APSURANS

igorous and energetic APSURANS spent Saturday morning April 19 luxuriating in the warm spring air under the tutelage of retired botany professor Wayne Chester. Wayne joined us for our spring wildflower pilgrimage on the Clarksville Greenway walking trail.

The Clarksville Greenway, completed under Mayor Johnny Piper in 2010, extends approximately five miles along the bed of the abandoned Tennessee Central Railroad. The north segment is the shortest, flattest portion of the trail and extends approximately two miles north from the trail head at the end of



Pollard Road. Wayne wowed us with his knowledge, insights and humor as he described and identified some 20 different species of wildflowers decked out in their finest spring colors.

All of us noticed that the particularly cold winter, by local standards, and the abundant late winter moisture had produced a bumper crop of floral beauties. The many wildflower species observed included Bloodroot, red and white Trillium, Virginia Creeper and Indian Strawberry.

Wayne showed the group that the juice of the Bloodroot did in fact resemble blood and thus was aptly named by the Native Americans and early settlers of our region, who believed it was a good medicinal plant for blood conditions.

Flea Beauty, alleged to kill fleas, also amused participants. Other species observed included blue, yellow and white violets, Butter Weed, and Paw Paw.

All in all, the participants enjoyed the weath-

er, flowers, instruction and camaraderie immensely. We especially thank Wayne for still another delightful lesson on the wonders of nature. What a way to celebrate Spring, 2014!

n behalf of this year's membership and nominating committees, I invite you to attend the yearly membership meeting on June 4. The nominating committee this year consists of Joe Filippo, Meredith Gildrie, and myself. We present the following suggested slate of officers and one new director for 2014-2015: For president, Aleeta Christian; vice-president, Hester Crews; secretary, Barbara Wilbur; and as a new director, David Kanervo. The other positions are not up for election this year. Additional nominations may be made by mail to the Nominating Committee, APSU Retirees Association, Box 4426, Clarksville, TN 37044, to be received by the committee no later than seven days prior to the election on June 4.

To clarify a rather confusing section of the bylaws on elections and terms of office, we are proposing minor changes to the wording of *Article IV*, *Administration*, and the addition of a letter system to distinguish among the kinds of directors and terms served by each. These changes will not affect the elections this June 4.

We will ask you to vote on the following proposed new system for defining and identifying the directors and their terms:

Directors: Directors A-H shall serve terms based on the following designations and responsibilities. Directors A-E may be re-elected after one intervening year. Directors F-H shall hold office based on the qualifications described below.

Director A	2-year term	
Director B	2-year term	
Director C	3-year term	
Director D	3-year term	
Director E	4-year term	Parliamentarian
Director F	Indefinite	Publicity Director, appointed/reappointed by the Board
Director G	3-year term	Ex-officio, immediate past president, eligible for re-election with no intervening year
Director H	Indefinite	University representative, serves at the pleasure of the president of the University

Membership dues due by July 1



ust a friendly reminder here that annual dues of \$25 for members and associate members are due by July 1. Please send to APSURA at the address listed on the right.

If you are a new retiree, remember that membership is free for the first full fiscal year following your retirement. That is, if you retired or retire from APSU at any time between July 1, 2013 and this July 1, 2014, your membership is free for the entire fiscal year July 1, 2014-July 1, 2015. The only requirement for membership is that you sign and submit a membership form such as the one on the back of this newsletter. Associate memberships work the same way.

Dues are used to defray the costs of printing, mailing, supplies and other operating expenses. At the end of each year any money remaining is moved into the scholarship account. Our goal for the scholarship account is to have a fully funded endowed account within a few more years. Several people have become lifetime APSURA members by giving \$500 to the account, which can be given in several increments. All dues and scholarship donations are considered contributions to the APSU Foundation, and thus are fully tax deductible. When you are renewing your annual dues, consider adding a little extra for the scholarship fund.
