1. Remarks

Senate President Dr. Mickey Wadia (5-8 minutes)

2. Old Business

Faculty Senate Absences - Amendment to the Bylaws – Gina Garber (5-8 minutes) Action Item Bylaws: Article III Attendance, Section C:

Faculty Senate Secretary Gina Garber presented the proposed language to the Attendance section of the Bylaws so that it would comply with the Parental Leave Policy and Family Medical Leave Act and define the number of absences a senator can miss during an academic year. That number is three (3) with their seat becoming vacant on the fourth (4th) absence.

SASI Report – Dr. Vikkie McCarthy (5-8 minutes)

SASI Report:

Dr. Vikkie McCarthy introduced the members of the SASI Committee: Tim Leszczak, John Phillips, Jennifer Thompson, and Tim Winters. Together they ranked the 57 proposals and selected 36 to fund. Over \$150,000 in grant proposals were submitted. The SASI Committee did a good job spreading the money throughout the departments. Faculty Senate Bylaws Article III, Section C Attendance Current Language

Section C. The office of any Senator who has missed three (3) meetings in an academic year shall be declared vacant and an election shall be conducted to fill the office.

APSU Policy 5:034 Paid Parental Leave

General Provisions



Paid parental leave is a benefit of employment and its use will not be considered as a negative factor in employment actions, such as hiring, promotions, and disciplinary actions, or under attendance policies. Use of paid parental leave shall not adversely affect consideration for future salary adjustments.

Departments should be supportive in managing paid parental leave request to allow faculty and staff to handle career and family responsibilities effectively and efficiently.

Workload issues should be dealt with proactively so that excessive work demands are not placed on other faculty and staff.

Faculty Senate Bylaws Article III, Section C Attendance Proposed New Language

Section C. The office of any Senator who has missed four (4) meetings in an academic year shall be declared vacant and an election shall be conducted to fill the office. Senators will be notified by the Secretary of the Faculty Senate after they miss the third meeting, that if they miss a fourth meeting their senate seat will become vacant. Faculty Senate will adhere to federal law (including the Family Medical Leave Act) and university policies (including APSU Policy 5:034 Paid Parental Leave) regarding attendance. The office of any Senator who has missed three (3) meetings in an academic year shall be declared vacant and an election shall be conducted to fill the office.
