31.1 – Approval of minutes from the July 12, 2016 meeting 30.0

Brown made a motion to approve the university policy committee minutes 30.0 from the July 12, 2016 meeting; Millard seconded the motion.

Committee approved the minutes by a unanimous vote.

New Business/ First Reading:

31.2 – Membership and Subscriptions 1:021 (previously 99:006)

Brown motioned to approve the policy on first reading. Gandy seconded the motion. Robinson opened the policy up for discussion.

Discussion:

Brown mentioned that individual member fees are normally paid by the faculty and not the University. However, Byrd does receive payment for her individual membership fees. Brown mentioned how the travel office currently does not reimburse for the membership fee. According to the policy on page 2, the fee can be paid if the appropriate VP approves it; however, Byrd would prefer it to be the supervisor. Policy states that the President is the only one to approve exceptions. New membership subscriptions do have to go the VPs. Questions from the committee to be addressed at next meeting:

Is this policy a mirror of the most recent TBR policy?

- Does this have basis in state law?
- Does the President have to grant exceptions?
- Do we still have newspaper clippings?

31.3 – Delegation of Authority for Approval and Execution of Contracts and Agreements 1:010
