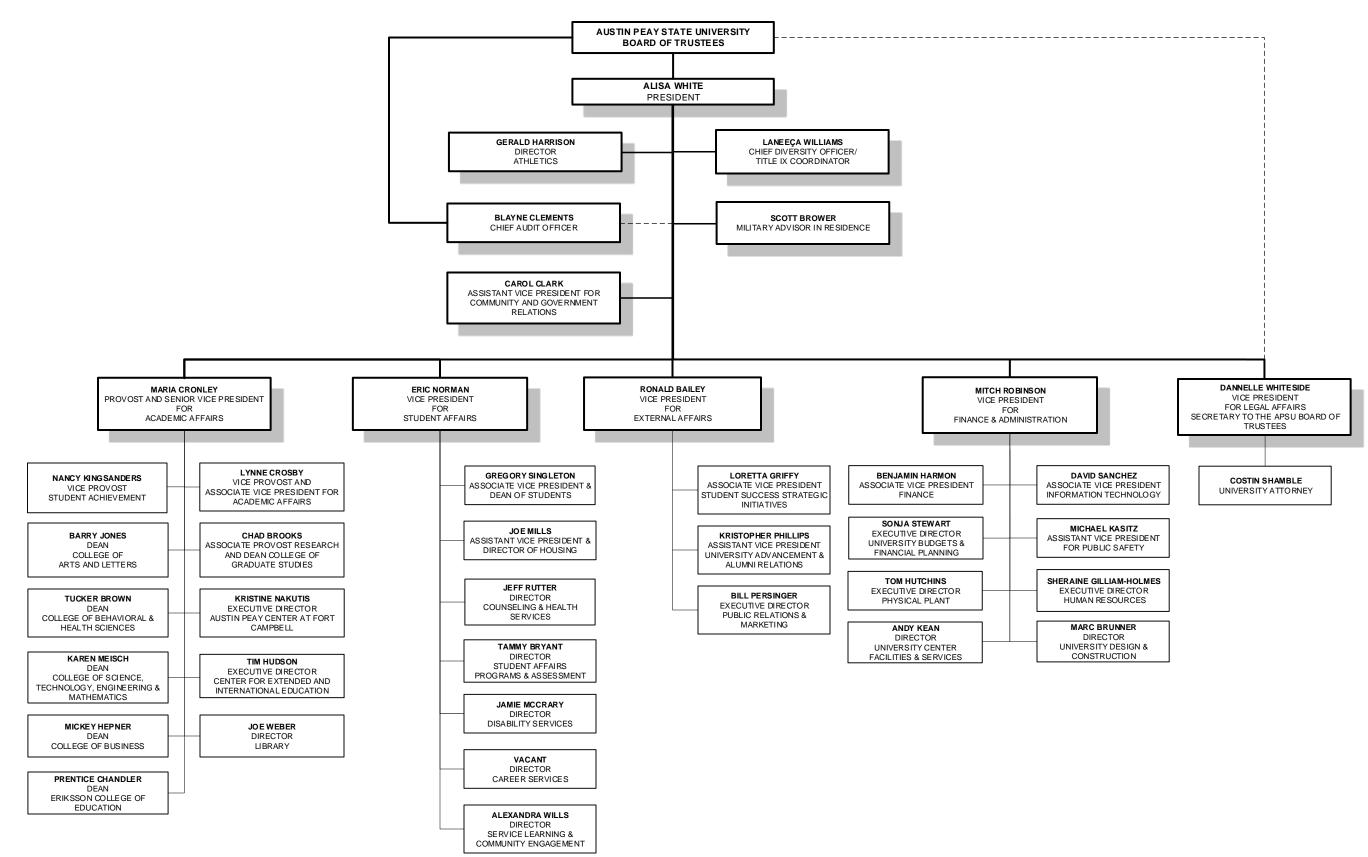

Building	System	Request	Scope	Submission	Justification
Sundquist Science Complex	Roof	\$3,200,000	Reroof Sundquist Science Complex with metal standing seam roof.	July 2020	Shingles need to be replaced often after high-wind storms. The membrane on the flat portion of the roof is nearing the end of its life. The metal roof eave flashing creates a water dam that causes back-ups under roofing and into brick veneer, resulting in mold and staining on brick faces at all locations.
Sundquist Exhaust System Controls	Controls	\$1,500,000	Replace fume hood control system supporting 110 fume hoods and 8 exhaust systems	July 2020	The electronic systems that control exhaust flow from the lab fume hoods has failed in several portions of the building.
