The use and/or possession of alcoholic beverages on University property is prohibited. The use and/or possession of alcoholic beverage <u>substitutes</u> (e.g., non-alcoholic beer) on campus is permitted.

A limited exception to the above statement is as follows: From time to time the President may designate a place on property owned or controlled by the University where alcoholic beverages may be served by alumni and foundation organizations at official fundraising events (e.g., donor cultivation, donor recognition, etc.) or official alumni-related events (e.g., Alumni Association executive committee functions, annual dinner meetings, etc.) sponsored by said organizations. However, the use and/or possession of alcoholic beverages at student functions is prohibited on property owned or controlled by the University even if the event is sponsored by the alumni or foundation organizations.

The sale of alcoholic beverages at a function is prohibited. "Sale" means any transfer, trade, exchange, or barter, in any manner or by any means, for consideration, including, but not limited to, requiring fees or the purchase of tickets for admission to the area or event at which alcoholic beverages will be served.

State funds may not be used for the purchase of alcoholic beverages.

The area where alcohol is served pursuant to the above noted exception shall not be in classrooms, labs, faculty or administrative offices, residence halls, student dining halls, student gathering areas, outdoor public areas, or athletic

facilities accessible to the public.

To request authorization to serve alcoholic beverages as described above, the Authorization to Serve Alcoholic Beverages Form must be submitted to the President of the University for consideration. This form is available in each division head's office (Vice President for Academic Affairs, Vice President for Finance and Administration, Vice President for Student Affairs, Vice President for Development and University Relations, Athletic Director, President).

Approval must be obtained in advance and can only be granted by the President.
