## **Approval of Minutes**

Trustee McInnis stated that the minutes for the December 2, 2022, Student Affairs Committee meeting were circulated before the meeting. She asked if there were any corrections or additions to the minutes. There were none.

Trustee McInnis moved to approve the minutes as written. Trustee May seconded the motion. A voice vote was taken, and the motion carried unanimously with four trustees voting yes.

#### **Action Items**

#### A. Consideration of Recommendation for Student Trustee

Trustee McInnis recognized Mr. Greg Singleton who provided information about the selection process for the student trustee. Applications for student trustee were reviewed by a screening committee comprised of three current students and two university administrators. The screening committee identified applicants to participate in interviews with the committee and then forwarded the names of two students to President Licari for consideration. The student trustee will serve a one-year term beginning on May 6, 2023, (the day after commencement) and running through the 2023-24 academic year. A video recording of the student who was recommended by President Licari was viewed.

Trustee Berg moved to forward the name of Jacob Knight to the full board for approval to serve as Student Trustee. Trustee May seconded the motion. A voice vote was taken and carried unanimously with four trustees voting yes.
