Discrimination and Harassment Based on Protected Categories other than Sex –
Complaint and Investigation Procedure 6:004

Page 11, number 5 – who decides level of discrimination or harassment? Who is the investigator? Needs to be defined. What do you do when the investigator is accused? Also, if there is a designee for the investigator then it needs to state that.

Page 12, number 5 – respondent does not receive a copy of the complaint against them. How can you be accused of something and not know what you are being accused of?

What is the student policy and why can't they be the same? It seems the expectation and flow can be made the same for students and faculty/staff.
