# 30.1 – Approval of minutes from the June 14, 2016 meeting 29.0

## 30.4 - Travel Policy 4:106 Own Travel Policy

Gandy made a motion to approve the policy on first reading. Van der Merwe seconded the motion. Robinson opened up the policy for discussion.

#### Discussion:

Byrd asked if we wanted to be so specific with current per diem rates. She also thinks the policy is too long. She would like to take to her constituents for review. Robinson noted some changes he wished to make to the policy. On page 23, number 2a, he would like to change "The current rate is \$23" to "The reimbursement rate when using a courtesy vehicle is currently \$.23 a mile." On page 26, Letter "C", number 2 where it states "specific guidelines for travel groups", we currently do not have any guidelines and he suggested possibly forming an ad hoc committee to set some guidelines. Gandy suggested to either set guidelines or remove the sentence from the policy. Jackie Struckmeyer will get in touch with MTSU and provide us with their current guidelines. TN Tech might be contacted as well. Student Liability waivers were also discussed and van der Merwe and Gandy think we should get waivers signed.

### Discussion:

Robinson recommended forming a group consisting of representatives from Staff Senate, SGA, Faculty Senate, HR and Student Affairs to revise the policy. Honea seconded the motion.
